- **New Releases**
  - o Hoot/Wisdom Recordings released three singles, one album, and one EP this semester.
  - o Three new singles are close to completion; also, there are recordings planned for the Fall Semester.
  - o Michael Zager produced *The 'Night' Holocaust Concert*, which was recorded in Hannover, Germany, on January 27, 2020—the 75th Anniversary of the liberation of the

Auschwitz Concentration Camp. There were 3,600 people in attendance (sold out). The orchestra is from Kaliningrad, Russia, and the Choir from Lithuania and Germany. There was a total of 110 musicians and singers. The audience applauded for approximately 12 minutes. Hoot/Wisdom Recordings will release the album.

- o We licensed the master recording of "The Hamburger Song" to a nationally syndicated television program called *TrueSouth*.
